Insuance/Effective Date of the Permit: A Permit authorizing the use of the access and/or recognizing completion of the project will be issued and become effective when it is determined that compliance with all conditions, specifications, and restrictions described in the Notice of Permit Action are met. The North Hero Selectboard, with the assistance of the Public Works Department, will have the authority and responsibility to determine when the conditions, restrictions and specifications defined above are met.

****CULVERT POLICY (adopted April 6, 2009)****

Culverts will be no less than 15" (inches) in diameter and no less then 30' (feet) long unless approved by the Public Works Department to change the diameter or length of any culvert.

Existing culverts will be replaced if need be by the Town of North Hero when new road projects are being done; otherwise it will be the responsibility of the property owner to see that culverts are properly installed.

Property owners installing their own culverts will review requirements with the Public Works Department before installing any culverts.

Notice: It is the determination of the North Hero Selectboard that all conditions, restrictions, and specifications described in the Notice of Proceed have been complied with and are hereby incorporated into the issuance of this permit will remain in force as long as the present land use continues. **Any change in the present land use will require a new permit.**

This permit is issued in accordance with Title 19, Section 1111, V.S.A. relative to all highways within the control and jurisdiction of the Town of North Hero. The issuance of this permit does not release the applicant from any requirements of statutes or ordinances ruled by other local, regional or state agencies. Violations to the permit are subject to the penalties set forth in Title 19, Section 1111, V.S.A. of fines not less than \$100 nor more than \$10,000 for each violation. Any damage caused to the town highway resulting from an activity authorized by the issuance of this permit is the responsibility of the applicant to repair as set forth in Title, Section 1108, V.S.A. Repairs must meet the minimum standards defined by the Road Forman. This permit shall not be valid until the permit holder records the Notice of Permit Action and the issued Permit which recording shall be at the applicant's expense.
